- TSIG-sponsored session at GLC
  - TSIG was approved for funding to provide complimentary registration for GLC, but no one submitted a proposal.

- Information Technology Interest Group
  - At the GLA Midwinter meeting in January, the IT Interest Group expressed an interest in joining TSIG. Shortly after, a change in the chairship occurred and in discussion with the new chair, Thomas Waters, it was decided they would stay separate. Linh told them the door is always open.

- Robert Will we be issuing Continuing Education credits now since PACE has a process for that?
  - o Linh- All of the credits/certificates have been based off of the Carterette webinar series certificate, which Linh asked the Carterette group for permission to use. Linh received approval from Laura Burtle, GLA President, to use this certificate method. This all occurred before PACE set down their new policy. For the last workshop of the year Laura Burtle also gave approval for the continued use of the certificate's TSIG had been using during the year. Next year's workshops will use the new GLA Pace certificates.

• TSIG was the first group to be profiled in NMRT's newsletter (summer issue). They asked to do a special feature on our Interest group. They will continue to spotlight divisions, interest groups and committees.

- Proposed bylaw changes were put to a vote in September for possible edits to flow with the GLA bylaws. The proposed changes were as follows:
  - Edited wording to align with GLA Bylaws
  - Quorum: 5 members, to "members present"
  - O VOTE: 22 = yes, 1 = no (majority vote of those present to pass). If the GLA executive board approves it, then the changes will be implemented in the next year.
- FYI: GLA listserv moving to Google Groups. Divisions, Interest groups, committees all getting their own email. Moving forward if you receive an email from technicalservices@georgialibraryassociation.org, then that is from TSIG.
- FYI: GLA Forums: in membership portal, Wild Apricot
  - o Linh provides instructions for navigating to and signing in to the new GLA forums page. Linh shows the Forums tab at the top of the screen with the blue bar, and shows where to find the Interest Groups forum and how to navigate to the TSIG tab. (Linh provided background: Oct 2011 minutes Sofia Slutskaya asked if there was TSIG mailing list. Cathy Jeffrey said 10 yrs ago Robin Fay started listserv hosted by UGA, but it didn't last. Elaine Hardy said GPLS had CATTECH for non-PINES libraries, so that was opened to all tech serv librarians/staff in GA.)
  - It's also mentioned that this is another way for GLA/TSIG members to communicate.
  - Shelley Rogers asked if this is only for GLA members, and Linh confirmed that that is correct. Shelley feels like the forum could be a great space for collaborating on conferences or presentations, etc...

discussion occurred on the slow blending of IT and Tech Services. There was mention of

the electronic resources interest group and whether it's the same as the IT interest group. Linh mentioned adding e-resources to our group years ago. The idea of more outreach to e-resources librarians was suggested. Outreach/workshops could pull some in with programming geared towards them.

• Amy Parsons mentions they implemented OpenAthens about a year ago and it's worked relatively well for them.
