New Business

The agenda of discussion items was as follows:

Georgia State University and Georgia Perimeter College merger Carterette series NISO webinars Metro Atlanta Area Cataloging Group informal meetings Call for COMO 2015 topics

1. Georgia State University and Georgia Perimeter College merger Linh mentioned the recent news that Georgia Perimeter College will be merged with Georgia State University and suggested that we may wish to hear about the effects at next year's meeting.

2. Carterette series

Linh has received a request for possible speakers and topics for the Carterette series. Anyone interested should let Linh know and give her their name, library, email address and topic.

3. NISO webinars

Robin Fay posted a link to NISO (National Information Standards Organization) webinars on the Technical Services Interest Group's Facebook page. Only voting NISO members may receive the webinar subscriptions packages and Robin has volunteered to do a fundraiser drive if the group is interested. Cathy Jeffrey suggested that TSIG can ask GLA to request funding from the budget committee if enough members are interested. As there are further considerations such as having to meet in a central location to share the log-in, it was decided to table the discussion until Linh can gather more information on the webinars and what would be required to make them available to TSIG members.

4. Metro Atlanta Area Cataloging Group informal meetings

Amy Eklund and Susan Wynne have begun arranging informal meet-ups and "un" conferences for library staff in technical services, metadata and cataloging positions. The first meeting included nine people who met at The Wrecking Bar in Atlanta in December 2014. This was followed with a survey to gage interest, suggested topics and convenient times as well as possible names for the group. They would like for the group to have events a few times each year, always keeping the meetings informal.

5. Call for COMO 2015 topics

TSIG sponsored COMO sessions have formerly been scheduled with round tables for cataloging, acquisitions, e-resources and serials on a rotating yearly basis. As some of these panels have been under attended, it was suggested either the focus should be combined with other subjects or perhaps the rotation should simply be ended while striving to maintain inclusiveness for all members of TSIG.

There is enough interest in e-resources to sponsor a related presentation each year. Kara Mullen will submit a proposal for an EZ-proxy session and Shelley Rogers volunteered to look for people at University of West Georgia to serve as panelists; a solicitation for panel members will also be sent out on the GLA listserv.

Interest was expressed in a program on conducting inventory, with topics of discussion including catalog migration and/or consolidation.
