## **General Discussion**

#### **NISO** Webinars

Linh distributed flyers with the NISO (National Information Standards Organization) webinar schedule for 2015. Consideration was given to asking the five institutions in Georgia that are already NISO members if they would open their live webinars to TSIG members, but it was determined that this would not be a fair practice. The group considered whether or not the webinars would be valuable enough to have GLA apply for NISO membership and pay dues of \$630 per year. An informal poll was taken of who would willing to host webinars and how many would likely to travel to a distant site to attend. GLEAN (Georgia Library Education Access Network) would be able to store archives of the webinars. There is also an alternative suggestion that TSIG could bring in presenters from NISO to the Carterette Series. Robin Fay will help Linh further survey the GLA membership for interest and commitment, and a proposal will be submitted at the 2016 GLA Mid-winter Meeting.

## Electronic resources interest group

It was asked if a separate group should be split off from TSIG for e-resources. Such a split would have to be taken to the GLA Executive Board for approval. The overall consensus of the group was that more should be done to make e-resources librarians and staff feel welcome in TSIG since their roles are so intertwined with that of the group.
